4. The purpose of processing personal data	<p>The right to participate in the Annual General Meeting of YIT Corporation on March 16, 2023, is based on this data file.</p> <p>The data are only used for the purpose of printing out the list of participants, list of votes, and ballots, and for carrying out the voting. A list of participants will be appended to the minutes of the Annual General Meeting. The list is based on this file, and it contains the persons who attended the meeting. The only data contained on the list of participants are the names of shareholders, any proxy representatives and assistants, and the number of their shares and votes.</p>
5. Data content of the file	<p>When a shareholder registers online or by email or mail, Euroclear Finland Ltd collects the data technically. The data connection between the user's browser and Euroclear Finland Ltd's server is SSL encrypted. The following data can be collected using this service: name, personal identification number/business ID, phone number, email address, book-entry account number, number of shares and votes.</p> <p>The book-entry account number is only used for identification in Euroclear Finland Ltd's system, and it is not disclosed to the controller.</p> <p>The controller may receive the voting information of individual shareholders, if needed in order to confirm the voting result.</p>

<p>6. Regular sources of data</p>	<p>Participants enter their own data when they register online. If they register by email or mail, they give their name, personal ID/date of birth or business ID and address, as well as other information required for participation to the Euroclear Finland Oy. The system uses the given information to compare the data with the shareholder register maintained by Euroclear Finland Ltd and extract the shareholding information of the shareholder from the register. In the case of an authorisation, the person will also enter/give the necessary personal data of the representative.</p>
<p>7. Regular destinations of disclosed data and the transfer of data to countries outside the European Union or the European Economic Area</p>	<p>Data are not disclosed.</p>
<p>8. Security principles of the data file</p>	<p><i>A. Manual register</i> The list of participants referred to in section 4 is stored as an appendix to the minutes of the meeting.</p> <p><i>B. ADP register</i> Is stored during the registration period for the Annual General Meeting and until the end of the meeting. The access rights to data saved on ADP media are restricted and secured with a user ID and a password.</p>
<p>9. Right to inspect</p>	<p>Shareholders have the right to inspect the data in the shareholder register of YIT Corporation at Euroclear Finland Ltd.</p> <p>Shareholders can inspect their own registration data by contacting the person specified in section 2.</p>
<p>10. Right to request rectification of data</p>	<p>The data subject has the right to request the rectification of data he/she entered at registration, by contacting the person specified in section 2 before the end of the registration period for the Annual General Meeting, March 13, 2023 at 10:00 a.m.</p>
