# YIT restates financial information for 2022 and Q1/2023 reflecting the new organisational structure

YIT has simplified its organisational structure as part of the transformation program. The new organisation consists of three business segments: Housing, Business Premises, and Infrastructure. The operations in the former Property Development segment have been allocated to the other segments and Group Functions.
